Disaster Site Worker Syllabus

Time: 16 hours

Maximum Class Size: 8

Prerequisites: OSHA 10

Course Description: The goal of this course is to provide Disaster Site Workers an awareness of the safety and health hazards they may encounter as well as of the importance of respiratory and other personal protective equipment and proper decontamination procedures that may be used to mitigate the hazards. Participants will support the use of an Incident Command System through the safe performance of their job responsibilities. They will be able to show awareness of effects of traumatic incident stress that can result from working conditions and measures to reduce this stress. This course emphasizes knowledge, precautions and personal protection essential to maintaining a worker's personal safety and health at a disaster site. Workers will perform an inspection of an appropriate air-purifying respirator, don the respirator, and perform a user seal check, and doff the respirator. This training provides students an opportunity to practice their new knowledge, skills, and attitudes through discussion, planned exercises, demonstrations, and presentations.

Goals/Objectives/Student Learning Outcomes:

- Proper Inspection of an air-purifying respirator
- Don and doff an air-purifying respirator; and
- Respirator user seal check
- Describe Incident Command/Unified Command
- Given a series of scenarios, identify possible:
 - Potential safety and health hazards
 - Health hazards
 - CBRNE Agents
- Given a series of scenarios, describe required:
 - o PPE needed for the job tasks
 - Personal hygiene and decontamination issues
 - Respiratory protection
 - Decontamination
- Define the term 'Critical Incident Stress Awareness'
